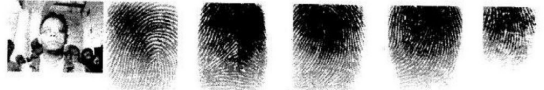

WHEREAS :-

(i) The settlor desires to establish a fund solely for SCHOOL/COLLEGE HOSPITAL & EDUCATIONAL PURPOSES and not for purposes of profit and, and for such purpose has made over a sum of Rs. 5000/- (Rupees five thousand) only to the Trustees by way of initial contribution.

(ii) The Trustees have agreed to become Trustees and to hold and apply the said sum of Rs. 5000/- (Rupees five thousand) only and all usufructs thereof plus all gifts, contribution, subscriptions and

NOW THIS DEED WITNESSES as follows :

1. The Trustees hereby declare that they and the survivors or survivor of them or other Trustees or Trustee hereof for the time being will hold the said sum of Rs. 5000/- (Rupees five thousand) only made over by the settlor to the Trustees as aforesaid and the usufructs thereof and all gifts, contributions, subscriptions donations bequests and other money or property as and when the same shall be paid to or vested in them and the money, investments and property from time to time representing the same upon Trust to apply the same for the sole purpose and advancement para Medical education not involving the carrying out of any activity for profit in the territories of India provided however, no part of the fund income be applied to any purpose outside the India except in accordance with the approval of the Central Board of Revenue, Government of India.

2. The objects and purposes of the trust are as follows :-

- (a) To impart, promote and spread education in I.T.I., Para Medical, Engineering College, Nursing College. Pathologically Laboratory Technician (M.M.L.T) Nursing X-Ray Technician (D.M.R.T), E.C.G. (D.E.C.T) Physio - Therapy Technician (D.P.T.) etc. as per the norms of any university council board or any

5. The member of the Trustees shall not be less than five and not more than nine. The Trustees shall be Trustees for their life time but any Trustees may resign by giving notice in writing to his co-Trustees and shall also cease to be a Trustee if requested in writing by at least Three fourths of remaining Trustees or the number nearest thereto. Appointment of Trustee either to fill up a vacancy or as additional Trustee (s) shall be by unanimous resolution of the Trustees for the time being.
6. The management and control of the Trust for the purposes of managing the Trust affairs and properties, and carrying out the objects of the Trust aforesaid, shall be vested in the "BOARD OF TRUSTEES" headed by settlor/author of the Trust till his life as the chief Trustee of the Trust. and consisting of all the Trustees named above i.e. the existing Trustees for the time being. The Board of Trustees (in short the Board) shall elect the office bearers thereof yearly/two/three/five yearly which shall be as follows :-
- (i) Chief Trustee " or Director in Chief"
  - (ii) Managing Trustee or Managing Director"
  - (iii) "Finance Trustee" or Finance Director' or Treasurer"
  - (iv) Trustees" or Directors"

The Trustees with not be entitled to receive any remuneration as trustee but any reimburses themselves of all expenses actually incurred by may get honorarium for whole time rendered by them in

connection with Trust or their duties relating thereto.

7. The profits, income and property of the Trust will be applied solely for the promotion of the objects of the Trust, as set forth above and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonuses or otherwise whatsoever by way of profit to any person.

Provided that nothing herein contained shall prevent the payment in good faith of remuneration of any officers or servants or employees of the Trust or other persons in return for any services rendered to the Trust.

8. The Board shall without prejudice to the generality of the objects and powers above named have power to do all or any of the following things that is to say :
- (a) To enter into contract and borrow money for the purposes of the Trust and management of its properties and assets.
  - (b) To appoint officer and servants at such remuneration (if any) as they think fit.
  - (c) To receive grants, donations and subscription.
  - (d) To make such Rules and regulations from time to time for the management and conduct of the affairs of the Trust it properties and assets.
9. The Trustees/Board with also have the following powers:-
- (a) To apply the whole or part of the income or accumulation thereof or

whole or part of the corpus of the trust properties for one or more of the objects of the Trust as the Trustees may from time to time determine.

- (b) To help, contribute, promote take over of amalgamate with any other society, Trust, Body or institution whether incorporated or not for the objects similar to those of the Trust herein.
- (c) To invest and keep invested the trust properties either in the purchase or mortgage or immovable properties or in shares, debentures or other securities or any business undertaking and investments and alter vary or transpose such investments from time to time as the Board shall in its absolute discretion think fit.
- (d) To sell dispose of, alienate or otherwise deal with any property movable or immovable comprising the trust fund.
- (e) To let out, premise any immovable properties comprised in the Trust fund on such term and conditions as the Board shall think fit.
- (f) To open account with any Bank to operate such accounts and to give instructions to provide for opening and operation of such accounts by two or more the Trustees or by two or more agents appointed by the Board.
- (g) To adjust, settle compromise, compound refer to the Arbitration all actions, suits claims demands and proceeding regarding the trust properties and affairs and that to appoint constituted attorneys or

agents and to delegate to such attorneys or agents all or any of the powers vested in them under these presents and from time to time remove such attorney or agent and to appoints other or other in his or their place.

- (h) To make, vary alter or modify schemes rules of trust and regulations for carrying out the objects of the trust and for the management of the affairs thereof and of running any other educational institution of the furtherance of the objects of trust and otherwise for giving effect to the objects of the trust.
- (i) To set apart the whole or part of the income or the corpus or part thereof for any of the objects of the trust.
10. The Board may from time to time frame rules for the conduct of the affairs of the trust and regulating the meeting etc. of the Trustees. In absence of such regulation.
- (a) All matters will be decided by majority and three trustees shall form quorum for the meeting of the trustees.
- (b) Resolution passed without any meeting of the trustees and evidenced in writing under the hands of three fourths of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of the Board of trustees.
- (c) It is expressly declared that no part trust property or its income shall be applied for any purpose which is not educational purpose in law
